<u>Superintendent of Streets:</u> Update: Sluiceway by Benway – DOT? No update. Mayor Damon reported that the pothole on Morris Hill will be repaired by the Town of Veteran. The Town of Veteran will soon be using the street sweeper to sweep the streets. - Assessment Roll Resolution: **WHEREAS**, THE Village Board on the 5<sup>th</sup> day of February presented a tentative Assessment Roll to the Village Clerk, **NOW THEREFORE BE IT RESOLVED**, that the Assessment Roll as presented to the Clerk be duly adopted, verified and filed with the Village clerk; and **BE IT FURTHER RESOLVED**, that the Village Clerk is directed to advertise within 10 days the filing of said assessment roll. A motion made by <u>Trustee Kraus</u> and seconded by <u>Trustee Auld</u> to adopt the resolution concerning the assessment roll. VOTE: All Ayes.
- Tax Cap Override- A motion was made by Mayor Damon and seconded by Trustee Auld to adopt the following; WHEREAS, the adoption of the 2024-2025 Budget for the Village of Millport will require a tax levy increase that exceeds the tax cap imposed by state law as outlined ing General Municipal Law Section 3-c adopted in 2011; and WHEREAS, General Municipal Law Section 3-c expressly permits the Village Board to override the tax levy limit by a resolution approved by a vote of sixty percent of qualified board members; NOW THEREFORE BE IT RESOLVED, that the Board of Trustees of the Village of Millport voted and approved to exceed the tax levy limit for the 2024-2025 fiscal year. Vote: All Ayes.
- Approval was given to IDDR to set up a a domain site for the ability to change our e-mail from Road Runner to G-Main in the estimated amount of \$170.00. The motion was made by <u>Trustee Auld</u> and seconded by <u>Trustee Trimber</u>. **Vote**: All Ayes.
- Earth Day this year is April 22. The Village workday will be on 4/20. There was mention that there is an area on Sundown Rd. that is in desperate need of cleaning up.
