Code Enforcement: Report received. June 11th sent a letter to Kenneth Klee 5566 Highland Ave. Violation of Codes. Unsafe Structure, 4 people living in home, trash and feces all over inside and out needed to be cleaned up. With the help of law enforcement, individuals moved out and into 19 Smith Rd. which law enforcement addressed.

Trustee Kraus mentioned that he noticed that Ken has 2 magnet signs on his truck stating "Town of Veteran Code Enforcement." He stated that the magnetic signs were \$75 ea. And thought maybe we need to get the same stating "Village of Millport Code Enforcement". The Board thought it was a good idea but will check with Ken and get his imput.
